2016/17 Results

Product Claims

Across the European region we have over 10,000 skus with environmental claims. Approximately 4,000 of these products are ranged to the UK and Ireland with approximately 2,000 available in the 2017 Office Depot UK catalogue. This equates to 21% of the catalogue products carrying a verified claim. Of the 2,000 "green" catalogue products, 992 are own-brand.
